The regular meeting of the Golf Course Green Committee was called to order 1:00 PM Wednesday, April 11, 2018 at City Hall, 401 California Avenue, Boulder City, Nevada, in accordance with the Committee's Rules of Procedure, with the following members present:

## **PUBLIC**

### **APPROVAL OF AGENDA:**

Member Effertz made a motion to approve the April regular meeting agenda; seconded by Member Critcher and unanimously approved.

1.       For possible action: Approval of the Minutes of February 2018 regular meeting

Member Effertz made a motion to approve the February regular meeting minutes as amended; seconded by Member Critcher and unanimously approved.

2.       For possible action: Discussion on old business from previous meetings concerning playability of the Boulder City Golf Course

Director Hall shared with the member's that he has not yet been able to get a quote from Charger Construction as of yet. He will work with the Public Works Department to have a few companies provide quotes for the remodel. Chairman Lemos asked about the results from the use of blue grass and was told they would really have to wait until fall to determine if the seed was beneficial. Members discussed fertilization and Superintendent Atkin said that the crew has fertilized specifically to promote bermuda growth. Member Weir asked about the bunkers. Members discussed the need to have sand added to the bunkers annually. Superintendent Atkin said the green's side bunkers have rocks because there is no liner. Members inquired if adding sand was part of the maintenance contract. Director Hall said that the addition of sand in the bunkers has been part of the

maintenance contract. Member Critcher said that summer would be the perfect time to add sand and Superintendent Atkin said he would look into it.

3. For possible action: Verbal reports from Golf Professional Tony Fiorentini and Superintendent Matt Atkin.

Golf Professional Fiorentini said that it has been a good first quarter and that they have future business opportunity with Black Mountain Golf Course closing June 1<sup>st</sup>. Golf Professional Fiorentini has already had tournament requests, league inquires and hopes to capture some of their golfers as well. He made a request for the maintenance crew to reduce the height of the rough areas this summer and Superintendent Atkin said the mower has already been lowered to reduce the height of the rough.

Superintendent Atkin told members of recent course maintenance including spring mowing, trimming and weeding. He said that the planter at hole #15 has been cleaned, low hanging branches have been removed, and a chemical application for goose grass was completed. He said the upcoming focus will be on top dressing to bring up the greens. He also let the members know that May 8 is aerification day. Superintendent Atkin expressed a need for divot replacement and sand application to be encouraged. Members discusses adding seed to the sand jugs. The members also discussed roping off the tees and greens to discourage cart use in these areas. They discussed signs and other notification of course rules and concluded that some people just don't follow rules. Golf Professional Fiorentini added that some people still drive their carts into the parking lot ignoring signage. Superintendent Atkin said that he would add sand to the jugs and put up ropes where he could.

4. For possible action: Verbal reports from Green Committee members regarding playability issues at the Boulder City Golf Course

Member Voerding said that the fairways are taking a long time to fill in and while some spots are real nice, many others are bare. Members discussed the overall appearance of the course and questioned the overseeding process from the fall because it is currently bare and spotty. Superintendent Atkin said that he believes that in two more months the fairways will be as nice as Boulder Creek. Director Hall said that the seed placement may need to improve and possibly cross sectioned for better coverage. Superintendent Atkin said that next fall they plan to adjust the aerifier to make more holes and also drop a pass of blue grass and rye seed to improve the overall condition of the greens. Chairman Lemos asked how trees were picked for plug placement because they are not always in the best location. Superintendent Atkin explained that the plugs are placed at the closest location but that he would do a more strategic plug placement in the future.

Member Voerding discussed the course being closed for aerification and the possibility of having the ladies play on the Wednesday after instead of the Monday before due to scheduling conflicts. Member Effertz asked about the dead trees on hole #10 and Superintendent Atkin said he was aware of one cottonwood tree. Member Weir said the tree trimming looks really good. He also asked about the trees along Buchanan Blvd.

and Superintendent Atkin said they are kept fuller to prevent balls from going in the street. Chairman Lemos inquired about the fountains and Superintendent Atkin said the filters need to be cleaned out on #17. He also said that the electrician has been busy doing repairs. Chairman Lemos also asked about the large amount of clover on the course. Director Hall suggested use of a product called Trimec weed killer. Chairman Lemos also inquired about the golf maintenance contract. Director Hall said that it is the same contract however it is currently expired and operating month to month soon to be addressed by the new City Manager. Director Hall commented on the ongoing cottonwood tree removal and told the members he had received a complaint from a resident concerned with the removal of trees. Director Hall asked Golf Professional Fiorentini and Supervisor Atkin to get together to plan the removal of every other tree and include new tree planting in the plan. Director Hall suggested planting pine trees or some other fast growing tree.

5. For possible action: Discussion and Appointment of Chairman and Vice-Chairman for the Golf Course Green Committee

Member Critcher made a motion to continue with Member Lemos as the Chairman and Member Weir as the Vice Chairman for the Green Committee for 2018. Member Weir seconded the motion, and the motion was unanimously approved.

6. For possible action: Committee Absences

June 13, 2018 is the next meeting.
