NOVEMBER 4, 2014

The results of the November 4, 2014 General Election were canvassed comparing the computer printout of ballots counted and the results thereof, with the official ballot statement for the 11 precincts utilized in this election.

We were unable to reconcile 15 ballots in four precincts, between the computer count and the roster count cast in the 11 precincts.

There were no tabulation errors in the 11 precincts, and the foregoing irreconcilable discrepancies would not alter the outcome of any race in this General Election.

Therefore, as the duly appointed Registrar of Voters of Clark County, Nevada, I do hereby approve the canvassed results of the General Election for certification.
