Dear Parents,

Welcome to the Safekey Program sponsored by the Boulder City Parks and Recreation Department. This program is designed to enrich your child in a recreation environment that is fun, friendly, safe and successful. Please review this entire packet to maximize your child's Safekey experience.

On school days, the program takes place at Martha P. King Elementary School before school from 7-8:10 a.m. & after school 2:40-6 p.m.. Please note that Mitchell Elementary School children will be escorted between Mitchell and King by Safekey staff. On days school is not in session, All Day Safekey takes place at the Recreation Department at 900 Arizona St. Safekey is closed on school holidays with the exception of Winter Break (partial weeks - check annual schedule) and Spring Break (one full week).

For the morning sessions parents must sign their child into Safekey and students are to check in with a Safekey leader when they enter the program. Each day, parents MUST SHOW current identification in order to sign their child out of the program. Parents will also be asked to identify the time of pick up. This process is important for the safety of the children and accountability at all levels. When you sign out your child, you will be able to see your account payment status. It is important to keep your child's account in a prepaid status to maximize the Safekey pricing structure. Further details are located within this packet.

When applicable, students are separated into age groups or by activities. Snacks are provided by Safekey on **afternoon school days only**. On days there is no school, snacks and lunch are to be brought to Safekey by your child. Homework time is provided Monday through Thursday. Students are required to bring their own pencil and paper. If homework is not assigned, reading time will be implemented. All school rules will apply at Safekey.

Boulder City Parks and Recreation Department Safekey Program

The Safekey Program is a year round program. Registration can be made at the Recreation Department, 900 Arizona Street and on school days at Martha P. King Elementary School Multi Use Room from 7-8:10 a.m. & 2:40-6 p.m.. Participation requires registration prior to attendance and fees are on a prepayment basis. The Recreation Department and City Pool can accept cash, check or credit card payments. The Safekey site can only accept payments in the form of a check. **School Day fees** are \$4 per morning & \$10 per afternoon when prepaid each day your child attends the program. A courtesy **drop in rate** of \$6 per morning & \$14 per afternoon will be offered for a two day grace period when fees are not prepaid. Those who do not catch up payments within a two day period are subject to a \$20 late fee per child and risk having services withheld until the payment issue is resolved. Non School Day fees are \$20 on Teacher Service Days, Spring & Winter Break. Summer rates are \$20 for full day & \$10 for half day when prepaid. Half day is 7am-12:30pm or 12:30-6pm. A drop in rate ~ \$28 full day & \$14 half day will apply when services are not paid prior to the child's arrival at Safekey. Please provide Safekey with your payment receipts for timely payment posting. Some field trips require an extra fee to participate. Field trip fees must be paid in advance and paid directly to Safekey staff. Children 60lbs and under are to provide a booster seat to participate in field trips. Please check the Safekey activity schedule and/or the Safekey sign-in table for field trip information. Field trip days may require your child to arrive by a specific time and he or she may lose their spot if late. Space is limited for field trips.

Please do not allow your child on school grounds in the morning before Safekey begins as there is no supervision. After school, a Safekey leader will walk your child from Andrew J. Mitchell to Martha P. King promptly at 2:50 p.m. so please have your child go to the front of the Andrew J. Mitchell office as soon as the bell rings. Please pick up your child through the door to the left of the main entrance at Martha P. King Elementary School. In the afternoon, your child must be picked up, no later than 6:00 p.m. A late fee of \$10 every ten minutes starting at 6:01 p.m. will be assessed for late pick-ups. **These fees must be paid before your child can return to Safekey.** If your child is not picked up by 6:30 p.m., your child may be transported to the City Pool at 801 Ave. B as a holding station and the Boulder City Police Department can be notified. All efforts will be taken to connect your child to an approved individual before contacting the police or Child Protective Services.

Snacks are ONLY offered in the afternoon on school days. On All Day Safekey days, children are to bring morning & afternoon snacks, lunch and plenty of drinks. **Please list any food allergies on the information sheet you complete when you enroll your child in Safekey.**

Please complete a ***Safekey Registration Form and Recreation Department Household Information Form*** at the time you enroll your child in Safekey. **This is an opportunity for you to tell us of any special needs your child may require.** Please be accurate in listing those who may pick up your child. Your child will only be released to those individuals on your registration form and or information sheet. Please sign your child out when leaving. **Identification is required to sign a child out of the program. Please update these forms when any of this information changes.**

Payments

- A child will be unable to attend Safekey until all unpaid balances are paid. If your child is unable to attend Safekey due to nonpayment and arrive at Safekey, they will be escorted to the school office. The school office will then follow Clark County School District procedures.
- Accounts left unpaid for more than two days are subject to an additional \$20 late fee per child and the family account will be placed on the nonpayment list and all family members will be unable to register for any City of Boulder City recreation activities, classes, events, programs, etc. until the account is paid in full.

- We understand that children may come from a situation where parents are separated or divorced. It is the responsibility of the parent who registered the child for the program to keep all payments up to date. If the account is left unpaid, the child will not be allowed to participate in Recreation Department activities, regardless of which parent is responsible for the balance.
- A returned check is considered nonpayment and the parent will immediately be placed on the nonpayment list. For repeat offenders, we reserve the right to place customers on a cash-only basis or to refuse service. There is a \$25 fee for returned checks.
- In order to ensure payment accuracy, please do not send payments to Safekey with your child. Payments from your child may not make it to responsible hands.
- **Once payment has been received, there will be no refunds.**
- Please save your receipts for tax and payment verification purposes. The Recreation Department does not issue an end-of-year statement.
- Safekey fees cover the cost of the Safekey Program and provide for an afternoon snack on school days only. This is a pre-payment program, please pay promptly.

Early Dismissal Days & CCSD Professional Development Day

Safekey is available on early dismissal days from the time children are out of school, until 6:00 p.m. Additional fees will apply. On Professional Development Days, All Day Safekey is \$20. Lunch is not provided on extended time days. Please make sure your child has ample food for the day.

Attending School Programs During Safekey Hours

Waivers are available for children to sign themselves in or out of Safekey for school programs on the school campus only. These waivers are only to be used for giving your child permission to leave Safekey for school activities such as clubs, to assist teachers or to attend school programs before or after school. Please note that staff will not be available to transport children from Mitchell to King after the 2:50 p.m. transition.

Your child must report to Safekey first to be signed in for the day by staff each day before requesting to sign out to attend another school program, classroom or club. Children are not permitted to leave Safekey on their own without a signed waiver (completed by a parent or legal guardian) on file. This privilege is subject to approval by a Safekey supervisor.

Personal Items

Personal items brought to Safekey are the responsibility of the student. Safekey is not financially responsible for lost or stolen items. Safekey staff will assist the children in finding a missing item.

Personal Cellphones

Safekey would prefer that no cellphones be brought to the program. If a child brings a cellphone it is their responsibility to keep track of it. Safekey does not take responsibility for children's cellphone use. They must be turned off and placed in their backpacks. Personal cellphone use is only allowed with staff approval. Cellphones are only permitted to be used for phone calls and not as a play toy. Should you need to contact your child, you may call Safekey at 702-287-6154.

Absenteeism

Please text or call the Safekey cell number (702) 287-6154 and leave a message if your child attends Safekey on a regular schedule and will be absent from Safekey. When the school needs to know your child is absent, so does Safekey.

Medication

Safekey does not administer medications. All prescription drugs must be self-administered or given by the child's school nurse prior to coming to Safekey. A medication release is required for a child to self administer medications. See the Safekey Coordinator to make these arrangements.

Health Records

Students not registered with the Clark County School District (or private school), with immunization records on file at these institutions, must provide immunization records that meet the Southern Nevada Health District requirements to enter school.

Inclusion

The Boulder City Parks and Recreation Department will provide service in the most integrated setting appropriate to meet the needs of participants with a qualified disability. Every effort will be made to provide reasonable accommodation. Although policies and practices may be revised, the Behavior Guidelines are applicable to ensure every ones safety and enjoyment. Participants needing accommodation are asked to contact staff two weeks prior to attending Safekey so that individual needs can be better met.

Filed Trips

Children 60 lbs. and under require the parent to provide a booster seat to travel in City vans. Prepayment is required for field trips and is paid directly to Safekey staff. The activity may require your child to arrive to Safekey by a particular time. He or she may lose their spot if they do not arrive at the designated time.

****The Boulder City Parks and Recreation Department will not be responsible for re-searching your payments for this program in order for you to file child care tax information. You must save your receipts. The City Federal Tax ID Number is 88-0084978.**

Students will not be allowed in the program without proper paperwork.

Unpaid balances for the Safekey Program that are not paid within the two day drop in rate grace period are subject **to a \$20 late fee per child and the family will not be allowed to register for other Recreation Department activities until late fees are paid.**

Safekey will make reasonable accommodations for all children to be successful in the Safekey Program. Safekey participants, including special needs children, must be able to follow Safekey staff direction, rules and meet behavior expectations. At any time that the Safekey Coordinator determines that a child is at risk of injuring themselves, others, or poses other safety issues, including yet not limited to, flight risk, hitting, biting, verbally antagonizing other children, or bullying, the Safekey program will take the following progressive correctional actions.

If there is an issue that prevents Safekey staff from being able to properly care for a child, the other children, or is harmful to staff, the following protocol will be used:

- 1st Time** - Child is directed to the correct behavior expectation.
- 2nd Time** - Child is sent to the redirection table and parent is notified.
- *3rd Time** - Child will be sent to the redirection table and a parent will be called to remove the child from the program, for that day, and/or the following day.
- *4th Time** - At this time, if the child’s behavior does not improve to meet expectations, the parent will be called to immediately remove the child from the program and there will be a three day suspension from the program.
- *5th Time** - At this time, if a child’s behavior does not improve to meet expectations, the parent will be called to immediately remove the child from the program and there will be a two week suspension from the program.

If the undesired behavior continues upon the child’s return to the program, the parent will be notified to immediately remove the child from the program and will not be allowed to return to the program until it is determined that the child can meet Safekey behavior expectations. This will be determined by the Safekey Program Coordinator meeting with the parent and child & a parent observation of the child in the program will be required to identify the precise behavior modification that is needed for the child to be allowed to return to the program.

***Note: Parent or authorized pick-up person must be available to pick up the child within 30 minutes upon notification that the child is to be removed from the program.**

If the behavior expectations is be met by the child, it may be determined that the child will not be eligible to participate in the Safekey Program.
