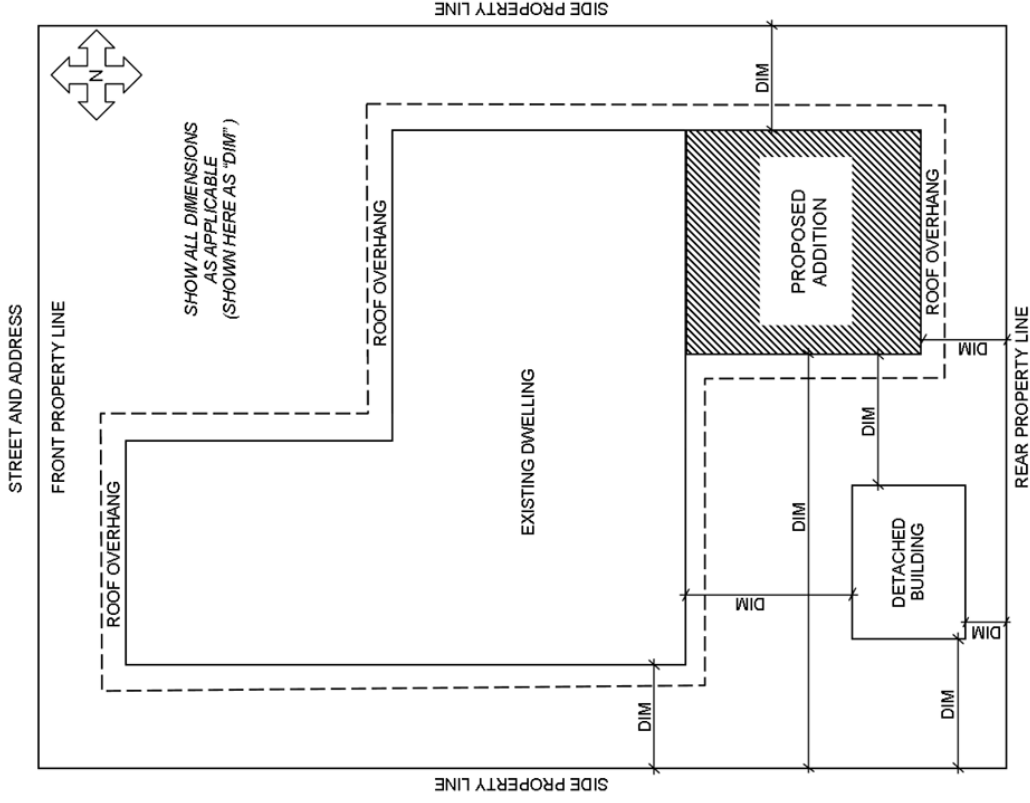

Electrical Service Site Plan Checklist

1. Provide 3 sets of plans and 2 sets of load calculations.
2. Indicate all proposed structures and existing structures AND their dimensions.
3. Indicate location of new and existing equipment.
4. Indicate size of new conductors and equipment.
5. Indicate all property lines and any easements.
6. Indicate all streets and alleys.
7. Indicate electrical points of connection and service routes.
8. Indicate property address.
9. Indicate properly oriented North arrow.
10. Sign and date the Site Plan.

All items must be indicated on the Site Plan before a plan review will be performed.
