Measured Attendance for City Council Meeting June 23

BOULDER CITY – The City of Boulder City will allow up to 15 attendees at the June 23, 2020 City Council meeting, by RSVP only. It will be the first opportunity for the public to attend a City Council meeting in person since March 10, 2020, just before Governor Steve Sisolak issued Directive 006 suspending public meetings. (Directive 021 extends the suspension of public meetings, allowing teleconference or videoconference with public comment by phone or email.)

Attendance will be capped at fifteen members of the public to maintain social distancing requirements. Preference will be given to applicants who have an item on the agenda. The meeting starts at 7:00 p.m. Others may reserve a spot by contacting the City Clerk's office at 702.293.9208. This will only be allowed at the City Council meetings; commissions and committees will still be held via live stream only.

Visitors will be required to answer the COVID-19 Self-Check Screening Questions and have their temperature taken. They are strongly encouraged to wear face coverings and may only use designated areas (Council Chambers and the restrooms). "Unfortunately, Clark County has experienced hundreds of new COVID-19 cases in the past two weeks, so I ask that those who attend please be respectful and honor social distancing," Mayor McManus said. "Staff has spaced seats six feet apart. While we are happy to welcome residents back, we also will continue to provide a live stream as well as options for public comment as we have in recent months."

Please see the updated information from Boulder City:

1. Mayor Kiernan McManus officially signed a Declaration of a State of Emergency in March 2020. The Declaration is posted at www.bcnv.org/CivicAlerts.aspx?AID=162.
2. Limited public attendance is allowed by RSVP at City Council meetings only. The City will still provide City Council, Committee and Commission meetings via live stream/teleconference. Visit www.bcnv.org/Council for information.
3. During these difficult times, we are suspending utility disconnections on a case-by-case basis. You must contact our utilities billing at 702.293.9244 to discuss.
4. City Hall has limited public access, by appointment only and after meeting specific guidelines, including:
 - Visitors answer the COVID-19 Self-Check Screening Questions and have temperature taken;
 - Visitors strongly encouraged to wear face coverings and to practice social distancing;
 - Visitors may only use designated areas for meetings with employees.
5. Most other City buildings and facilities are closed to the public until sometime in June. In many cases, City business can be handled by email or phone. Call City Hall at 702.293.9329 during regular business hours (limited hours Friday and Saturday) or use the directory at www.bcnv.org/Directory.aspx.
6. Utility, business license and permit payments can be made at the back window of City Hall. Payments can also be made online at www.bcnv.org, where you can set up autopay as well.
7. Police fingerprint services (for background checks) are temporarily suspended, and Nevada DMV services provided at the Police Department are suspended until further notice.
8. Nevadans seeking Unemployment Insurance Benefits can file online at <http://ui.nv.gov/css.html>.
9. Through June 30, the CCSD student food distribution pod is open from 7 a.m. to 10 a.m. Monday through Friday at Mitchell Elementary School. You must bring a student ID, know the student’s ID number, or child must accompany you for pick-up (may remain in car.) Details at <https://ccsd.nutrislice.com/menu>.
10. Albertson’s Grocery Store offers special hours for people with immune system issues, with physical impairments, and/or who are elderly: 7 a.m. through 9 a.m. on Tuesdays and Thursdays.
11. Three Square Food Bank is helping people sign up for food stamps. Call their office at 702.765.4030 Monday through Friday between 9 a.m. and 5 p.m. or visit www.threesquare.org.
12. Boulder City Hospital, the Southern Nevada State Veterans Home, and all nursing homes in Boulder City are restricting visitors. Please check with each location by phone for more information.
